

CAYO WEST

Polling Area No. 82

Commencing at a point, the said point being the confluence of a creek and the Macal River, the said point being opposite the village of Cristo Rey; thence southerly along the Macal River to a track south of Negroman Vilage; thence southerly then westerly along the said track to the western boundary of Benque Viejo Del Carmen; thence along the Said boundary to its junction with the Mopan River; thence upstream the Mopan River to its confluence with a creek east of Benque Viejo Del Carmen; thence upstream the said creek to its intersection with the international boundary between Belize and Guatemala; thence northerly along the said international boundary to its intersection with San Juan Creek; thence downstream San Juan Creek to its confluence with the Mopan River ; thence upstream the Mopan River to its confluence with a creek near Clarissa Falls; thence upstream the said creek to its intersection with the Western Highway, also known as the Benque Viejo Road; thence northerly along the Benque Viejo Road to the extension of a creek west of the village of Cristo Rey; thence easterly along the south bank of the said creek back to the point of commencement.

The afore described Polling Area No. 82 generally comprising the villages of Chial, San Jose Succotz, Clarissa Falls, San Francisco Farm and Negroman.

Polling Area No. 83

Commencing at a point, the said point being the intersection of a creek at the entrance of Benque Viejo Del Carmen Town and the eastern boundary of Benque Viejo Del Carmen Town; thence easterly then southerly along the said town boundary to a point having a scaled UTM coordinate of 273 380 meters east and 1888 043 meters north; thence east to the Mopan River; thence downstream the Mopan River to a point having a scaled UTM

coordinate of 271 664 meters east and 1888 538 meters north, said point being on a survey property boundary; thence along the said boundary to Church Street; thence east along Church Street to its junction with a creek at the entrance of Benque Viejo Del Carmen Town; thence downstream the said creek back to the point of commencement.

The afore described Polling Area No. 83 generally comprising the eastern portion of Benque Viejo Del Carmen Town and including the settlements along the Western Highway south of San Jose Succotz Village.

Polling Area No. 84

Commencing at a point, the said point being the intersection of a creek at the entrance of old Benque Viejo Del Carmen Town and the eastern boundary of Benque Viejo Del Carmen Town; thence upstream the said creek to Church Street; thence southwesterly along Church Street to a survey property boundary; thence along the said property boundary to a point of the south bank of the Mopan River, said point having a scaled UTM coordinate of 271 664 meters east and 1888 538 meters north; thence downstream the Mopan River to its confluence with a creek at the entrance of Benque Viejo Del Carmen Town; thence downstream the said creek back to the point of commencement.

The afore described Polling Area No. 84 generally comprising the western portion of Benque Viejo Del Carmen Town.

Polling Area No. 85

Commencing at a point, the said point being the intersection of international boundary between Belize and Guatemala and San Juan Creek; thence downstream San Juan Creek to its confluence with the Mopan River; thence upstream the Mopan River to its

confluence with a creek near Clarissa Falls; thence upstream the said creek to its intersection with the Western Highway, also known as the Benque Viejo Road; thence northerly along the Benque Viejo Road to a major track, the said major track leading to the settlement of Providencien on the bank of the western branch of the Belize River, also known as the Mopan River; thence westerly along the said track to the Mopan River; thence upstream along the west bank of the Mopan River to a track north of the Village of Santa Rosa; thence west along the said track to its intersection with the western international boundary between Belize and Guatemala; thence south along the said international boundary between Belize and Guatemala back to the point of commencement.

The afore described Polling Area No. 85 generally comprising the villages of Calla Creek and Santa Rosa.

Polling Area No. 126

Commencing at a point, the said point being the intersection of the Chiquibul Road and the Macal River at Guacamallo Bridge; thence southerly and westerly along the Chiquibul Road to where it meets the western international boundary between Belize and Guatemala; thence north along the western international boundary between Belize and Guatemala to a creek east of Benque Viejo Del Carmen; thence downstream the said creek to its confluence with the Mopan River; thence upstream the Mopan River to a point, said point being on a survey property boundary; thence east to a point having a scaled UTM coordinate of 273 380 meters east and 1888 043 meters north, said point being on the Benque Viejo Del Carmen Town boundary; thence northerly along the said boundary to a track leading to Negroman Village; thence easterly along the said track to its junction with the Macal River; thence southerly along the west bank of the Macal River back to the point of commencement.

The afore described Polling Area 126 generally comprising the villages of Arenal and Garbutt's Falls.
