

BELIZE RURAL CENTRAL

Polling Area No. 30

Commencing at a point, the said point being on the coast of the Caribbean Sea having scaled UTM coordinate of 1944488 meters north and 362937 meters east; the said point also being a survey property line; thence north west along the said survey property line to a point, said point having a scaled UTM coordinate of 1945309 meters north and 356111 meters east; thence south west to a point having a scaled UTM coordinate of 1945240 meters north and 355960 meters east, said point being its junction with the Northern Highway; thence southeast along the north-side of the Northern Highway to its junction with the Burrell Boom Road; west along the north-side of the Burrell Boom Road to intersection with the Belize River; thence downstream along the west bank of the Belize River to a point, the said point being the production of Javier Berbey Sr. Blvd. in the Vista Del Mar area to the river; thence northerly along the east-side of Javier Berbey Sr. Blvd to the coast of the Caribbean Sea; thence northerly along the coast of the Caribbean Sea back to the point of commencement.

The afore described Polling Area No. 30 generally comprising the villages of Lord's Bank, Bainton's Bank, Ladyville and all the settlements between the Northern Highway and the Sea from the Burrell Boom/Northern Highway junction to Belize River.

Polling Area No. 32

Commencing at a point, the said point being the junction of the Hattieville/Burrell Boom Road and the Western Highway; thence southerly along the Western Highway for an approx distance of two kilometers to a track; thence southerly along the said track to the Sibun River; thence upstream along the Sibun River to its intersection with the west

boundary of Belize District; thence northerly along the Belize district boundary to its intersection with the Big Falls Road; thence easterly along the Big Falls Road to its intersection with a branch of the Belize River, also known as Mussel Creek; thence upstream Mussel Creek to its intersection with the Burrell Boom/Bermudan Landing Road at Sebastian Bridge; thence easterly along the said road to a creek; thence southerly along the east bank of the said creek to a point having a scaled UTM coordinate of 1937951 meters north and 348404 meters east; thence east to a bridge situated 4 miles south of the village of Burrell Boom, said bridge being on the Burrell Boom/Hattieville Road; thence south along the said Burrell Boom/Hattieville Road back to the point of commencement.

The afore described Polling Area No. 32 generally comprising the villages of Gracie Rock, Jih Chan, La Democracia and all the settlements along the western Highway from Mile 19 to the Belize/Cayo District boundary.

Polling Area No. 33

Commencing at a point, the said point being the confluence of Burdon Canal and Sibun Canal; thence northeasterly along Burdon Canal to its confluence with the Haulover Creek; thence upstream along Haulover Creek to its confluence with Belize River; thence upstream along the north-bank of the Belize River to a point; the said point being on the west bank of the Belize River and having a scaled UTM coordinate of 1939654 meters north and 355954 meters east; the due west to a point on the Boom/Hattieville Road; thence south along the Boom/Hattieville Road to its junction with the Western Highway; thence southerly along the Western Highway for an approx distance of two kilometers to a track; thence southerly along the said track to the Sibun River; thence upstream along the Sibun River to its confluence with Boom Creek; thence north along Boom Creek to its confluence with Jones Lagoon; thence northerly along the east bank of Jones Lagoon

to its confluence with Burdon Canal; thence continuing northerly along Burdon Canal back to the point of commencement.

The afore described Polling Area No. 33 generally comprising the villages of Hattieville, Tropical Park, all the settlements along the Western Highway from the Belize City limits to Mile 19 on the aid highway and all the settlements along the Burrell Boom/Hattieville Road from a bridge situated four miles south of Burrell Boom on the said road.

Polling Area No. 35

Commencing at a point, the said point being the junction of the coast of the Caribbean Sea and the southern Belize District boundary; thence westerly then northerly along the said boundary to its intersection with the Sibun River; thence downstream along the Sibun River to a point having a scaled UTM coordinate of 350544 meters east and 1925919 meters north, the said point being on a property boundary; thence along the said property boundary to a point having a scaled UTM coordinate of 355180 meters east and 1920 001 meters north; thence to a point having a scaled UTM coordinate of 356422 meters east and 1920520 meters north the said point being on the west bank of the Northern Lagoon; thence along the west, north and then east banks of Northern Lagoon to a point having a scaled UTM coordinate of 361537 meters east and 1921746 meters north; thence to a point having a scaled UTM coordinate of 363583 meters east and 1921730 meters north; thence to a point having a scaled UTM coordinate of 363583 meters east and 1918848 meters north; thence to point having a scaled UTM coordinate of 364583 meters east and 1918856 meters north, said point being on the coast of the Caribbean Sea; thence southerly along the coast back to the point of commencement.

The afore described Polling Area No. 35 generally comprising the village of Gales Point, Manatee Beach and Northern Lagoon.

Polling Area No. 36

Commencing at a point, the said point being the confluence of Sibun Canal and the Caribbean Sea; thence west along Sibun Canal to its confluence with Burdon Canal; thence south along Burdon Canal to its confluence with Jones Lagoon; thence southerly along the east bank of Jones Lagoon to its confluence with Boom Creek; the southerly along Boom Creek to its confluence with Sibun River; thence upstream along south Sibun River to a point having a scaled UTM coordinate of 350544 meters east and 1925919 meters north, the said point being on a property boundary; thence along the said property boundary to a point having a scaled UTM coordinate of 355180 meters east and 1920 001 meters north; thence to a point having a scaled UTM coordinate of 356422 meters east and 1920520 meters north the said point being on the west bank of the Northern Lagoon; thence along the west, north and then east banks of Northern Lagoon to a point having a scaled UTM coordinate of 361537 meters east and 1921746 meters north; thence to a point having a scaled UTM coordinate of 363583 meters east and 1921730 meters north; thence to a point having a scaled UTM coordinate of 363583 meters east and 1918848 meters north; thence to point having a scaled UTM coordinate of 364583 meters east and 1918856 meters north, said point being on the coast of the Caribbean Sea; thence northerly along the coast back to the point of commencement.

The afore described Polling Area No. 36 generally comprising the villages of Freetown Sibun, Ferguson Bank, Egypt and all the settlements along the Sibun River from Sibun Bar to Egypt.
