

CAYO SOUTH

Polling Area No. 87

Commencing at a point, the said point being the intersection of the Baldy Beacon Road and the Brunton Trail; thence northerly along Baldy Beacon Road to Roaring Creek Road; thence northerly along Roaring Creek Road to its intersection with Barton Creek; thence northerly along the east bank of Barton Creek to its confluence with the Belize River; thence easterly along the south bank of the Belize River to a point having a scaled UTM coordinate of 297 809 meters east and 1905 044 meters north; thence southerly and across the western Highway to a track, the said track being west of Ontario Village; thence southerly along the said track to its junction with Roaring Creek; thence upstream Roaring Creek to its intersection with the Baldy Beacon Road; thence southwesterly along the Baldy Beacon Road back to the point of commencement.

The afore described Polling Area No. 87 generally comprises the villages of Blackman Eddy, Unitedville and Barton Creek.

Polling Area No. 88

Commencing at a point, the said point being on the south bank of the Belize River and having a scaled UTM coordinate of 297 809 meters east and 1905 044 meters north; thence southerly and across the western Highway to a track, the said track being west of Ontario Village; thence southerly along the said track to its junction with Roaring Creek; thence downstream Roaring Creek to a point on a survey property boundary, said point having a scaled UTM coordinate of xxx meters east and xxx meters north; thence to a point having a scaled UTM coordinate of 307 612 meters east and 1901 443 meters north; thence to a point having a scaled UTM coordinate of 307 230 meters east and 1902 073 meters north, said point being on a track; thence along the said track to a point having a scaled UTM coordinate of 306 785 meters east and 1903 640 meters north; thence to a

point having a scaled UTM coordinate of 305 166 meters east and 1905 611 meters north; thence to a point having a scaled UTM coordinate of 304 768 meters east and 1906 081 meters north, said point being on the Western Highway; thence westerly along the Western Highway to its junction with a road leading the Belize River in an area known as Machete Nile; thence northerly along the said road to its junction with the Belize River; thence upstream the Belize River back to the point of commencement.

The afore described Polling Area No. 88 generally comprising the villages of Ontario and Teakettle.

Polling Area No. 89

Commencing at a point, the said point being the intersection of Roaring Creek and the southern boundary of Belmopan; thence east along the said boundary to its intersection with the Hummingbird Highway; thence southerly along the Hummingbird Highway to its intersection with Caves Branch River; thence downstream Caves Branch to its confluence with Sibun River; thence upstream the Sibun River for an approximate distance of three kilometers to a survey property boundary; thence east along the said boundary to a point on a branch of Sibun River and also being the Belize/Cayo District boundary; thence southerly along Cayo District boundary to its junction with the international boundary between Belize and Guatemala; thence northerly along the said boundary to a point, , the said point being the intersection of the Chiquibul Road and the western international boundary between Belize and Guatemala; thence southerly and easterly along the Chiquibul Road to its intersection with the Macal River at Guacamallo Bridge; thence continuing easterly and northerly along the Chiquibul Road to its junction with the Brunton Trail; thence southerly and easterly along the Brunton Trail to its junction with Baldy Beacon Road; thence along the Baldy Beacon Road to its junction with Roaring Creek; thence downstream Roaring Creek back to the point of commencement.

The afore described Polling Area No. 89 generally comprising the villages of Caves Branch, Ringtail, Armenia, St. Margaret's, Roaring River and all the settlements up to mile 32 ½ on the Hummingbird Highway.

Polling Area No. 90

Commencing at a point, the said point being the confluence of the Belize River and Roaring Creek; thence upstream Roaring Creek to a point on a survey property boundary, said point having a scaled UTM coordinate of 307 612 meters east and 1901 443 meters north; thence to a point having a scaled UTM coordinate of 307 230 meters east and 1902 073 meters north; thence to a point having a scaled UTM coordinate of 306 785 meters east and 1903 605 meters north; thence to a point having a scaled UTM coordinate of 305 150 meters east and 1903 640 meters north; thence to a point having a scaled UTM coordinate of 305 166 meters east and 1905 611 meters north; thence to a point having a scaled UTM coordinate of 304 768 meters east and 1906 081 meters north, said point being on the Western Highway; thence westerly along the Western Highway to its junction with a road leading the Belize River in an area known as Machete Nile; thence northerly along the said road to its junction with the Belize River; thence downstream the Belize River back to the point of commencement.

The afore described Polling Area No. 90 generally comprising the villages of Roaring Creek, Camalote and all the settlements on Roaring Creek up to Roaring River.

Polling Area No. 90A

Commencing at a point, the said point being on the southern boundary of Valley of Peace and having a scaled UTM coordinate of 308 043 meters east and 1914 111 meters north; thence northerly along a road to the Belize/Orange Walk District boundary; thence easterly along the said boundary for an approximate distance of eight kilometers to a

track; thence southerly along the said track to a road; thence westerly along the said road for a distance of approximately one kilometer to a road; thence southerly along the said road to a road being the southern boundary of Valley of Peace; thence westerly along the said boundary back to the point of commencement.

The afore described Polling Area no. 90A generally comprising the village of Valley of Peace.

Polling Area No. 91

Commencing at a point, the said point being the confluence of Roaring Creek and the Belize River; thence upstream along the south bank of the Belize River to its confluence with Quaco Creek; thence upstream along Quaco Creek to a survey line, said line being the production of the southern boundary of Valley of Peace; thence easterly along the said boundary to a road; thence northerly along the said road to a point having a scaled UTM coordinate of 308 088 meters east and 1918 181 meters north, said point being its junction with another road; thence easterly along the said road for an approximate distance of one kilometer to a track; thence northerly along the said track to the Belize/Orange Walk District; thence easterly along the said boundary also forming Labouring Creek to a point on the Cayo/Belize District; thence southerly along the Cayo District boundary to a point, said point being on a survey property boundary; thence westerly along the said survey property boundary to its junction with the Sibun River; thence downstream the Sibun River for an approximate distance of three kilometers to its confluence with Caves Branch; thence upstream Caves Branch to its intersection with the Hummingbird Highway; thence northerly along the Hummingbird Highway to the southern boundary of Belmopan; thence easterly, northerly then westerly along the Belmopan boundary to its junction with Roaring Creek; thence downstream Roaring Creek back to the point of commencement.

The afore described Polling Area No. 91 generally comprising the villages of Cotton Tree, Beaver Dam, St. Matthews, Franks Eddy and More Tomorrow.
