COROZAL SOUTH EAST

Polling Area No. 45

Commencing a point, the said point being the intersection of the Libertad Road and the New River; thence north along said Libertad Road to its intersection with the Northern Highway; thence continue north along said highway for an approx. distance of 0.75 kilometers to a major track; thence along the west side of the major track to its junction with a road leading from Calcutta on the Northern Highway; thence east along the said major track to its junction with the Northern Highway; thence along the south-side of the Northern Highway to its intersection with the Corozal Town Boundary; thence south along the town boundary to a scale UTM coordinate of 352034 meters east and 2013517 meters north; and also being the boundary of lands now or formerly leased to Albert Vault; thence east along the boundary of the said lands to a point on the coast of the Caribbean Sea and having a scaled UTM coordinate of 352364 meters east and 2031509 meters north; thence southerly along the coast to the New River thence upstream along the New River back to the point of commencement.

The afore described Polling Area No. 45 generally comprises the villages of Ranchito, San Joaquin, Calcutta, Carolina, Aventura, San Maximo and all the settlements along the Northern Highway and Corozal Bay.

Polling Area No. 46

Commencing at a point, the said point being the intersection of the Corozal/Orange Walk District boundary and the New River; thence west along the said district boundary to a point having a scaled UTM coordinate of 340105 meters east and 2014641 meters north; thence north east to a scale UTM coordinate of 340409 meters east and 2014034 meters north; thence to a scaled UTM coordinate of 339875 meters east and 2014641 meters

north; thence north to a scaled UTM coordinate of 340640 meters east and 2017193 meters north, being a point on the southern side of the Caledonia Road; thence east along the Caledonia Road to a scaled UTM coordinate of 343447 meters east and 2016318 meters north; thence north and easterly to a scaled UTM coordinate of 345196 meters east and 2016257 meters north; thence continue east to a scaled UTM coordinate point of 344151 meters east and 2016938 meters north, being a point on the west bank of the New River; thence upstream along the New River back of the point of commencement.

The afore described Polling Area No. 46 generally comprises the village of Caledonia and all those areas south to the Corozal District boundary.

Polling Area No. 47

Commencing at a point, the said point being the intersection of the New River and the Corozal/OrangeWalk District Boundary; the downstream along the New River and more particularly along its west branch to its confluence with Corozal Bay; thence along the coast at Corozal Bay to Laguna Seca; thence along the west bank of Laguna Seca to its confluence with John Piles Creek; thence upstream along John Piles Creek to Progresso Lagoon; thence along the east bank of Progresso Lagoon to a point having a scaled UTM coordinate of 352 912 meters east and 2017 001 meters north, the said point being on a property boundary; thence along the property boundary to a point having a scaled UTM coordinate of 367 299 meters east and 2011 461 meters north; thence south to a point having a scaled UTM coordinate of 358 459 meters east and 1992 284 meters north, said point being on the Corozal District boundary; thence west along the said boundary back to the point of commencement.

The afore described Polling Area No. 47 generally comprises the village of Copper Bank, San Fernando, Progresso and Little Belize.

Polling Area No. 48

Commencing at a point, the said point being the confluence of Corozal Bay and Laguna Seca at its east bank; thence along the west bank of Laguna Seca to its confluence with John Piles Creek; thence upstream along John Piles Creek to Progresso Lagoon; thence along the east bank of Progresso Lagoon to a point having a scaled UTM coordinate of 352 912 meters east and 2017 001 meters north, the said point being on a property boundary; thence along the property boundary to a point having a scaled UTM coordinate of 367 299 meters east and 2011 461 meters north; thence to a point having a scaled UTM coordinate of 369 346 meters east and 2006 003 meters north; thence to a point having a scaled UTM coordinate of 370 155 meters east and 2015 898 meters north; thence to a point having a scaled UTM coordinate of 371 633 meters east and 2036 490 meters north, said point being on the coast of the Corozal Bay; thence westerly along the coast back to the point of commencement.

The afore described Polling Area No. 48 generally comprises the village of Chunox

Polling Area No. 49

Commencing at a point, said point being on the coast at Corozal Bay and having a scaled UTM coordinate of 371 633 meters east and 2036 490 meters north; thence easterly and then southerly along the coast to where its meets the Corozal/Belize District boundary; thence along the said district boundary to a point, the said point having a scaled UTM coordinate of 358 459 meters east and 1992 284 meters north; thence to a point having a scaled UTM coordinate of 369 346 meters east and 2016 003 meters north; thence to a point having a scaled UTM coordinate of 370 155 meters east and 2015 898 meters north; thence north back to the point of commencement.

The afore described Polling Area No. 49 generally comprises the villages of Sarteneja, Shipstern and lands now or formerly known as Bulk Head Lands.
