# DESCRIPTION OF POLLING AREAS AFFECTED BY REDIVISION OF ELECTORAL DIVISIONS <br> (Act No. 11 of 2005) 

## FREETOWN DIVISION

Polling Area No. 3B

Commencing at a point, the said point being the intersection of Independence Avenue and the coast of the Caribbean Sea; thence southerly along the east-side of Independence Avenue to the Northern Highway; thence west along the north side of the Northern Highway to its junction with the Belize River; thence downstream along the Belize River to its confluence with the Caribbean Sea; thence southerly and easterly along the coast of the Caribbean Sea back to the point of commencement.

## Polling Area No. 30A

Commencing at the confluence of the Belize River and the Caribbean Sea; thence southerly and westerly along the north-bank of the said Belize River to a point, said point being the production of Javier Berbey Sr. Blvd. in the Vista Del Mar area; thence northerly along the east-side of Javier Berbey Sr. Blvd to the coast of the Caribbean Sea; thence southerly and easterly along the coast of the Caribbean Sea back to the point of commencement.

## CARIBBEAN SHORES DIVISION

Polling Area No. 3A

Commencing at a point, the said point being the intersection of Independence Avenue and the coast of the Caribbean Sea; thence southerly along the east-side of Independence Avenue to its intersection with the Northern Highway; thence easterly along the north-side of the Northern Highway to its intersection with Button Wood Bay Blvd; thence north along the east side of Button Wood Bay Blvd to its intersection with the Coast of the Caribbean Sea; thence westerly along the said coast of the Caribbean Sea back to the point of commencement.

## PICKSTOCK DIVISION

## Polling Area No. 16A

Commencing at a point, the said point being the junction of Vernon Street and Sarstoon Street; thence north along the east-side of Sarstoon Street to Haulover Creek; thence upstream along the south-bank of Haulover Creek back to Central American Boulevard; thence south along the west side of Central American Boulevard to Vernon Street; thence east along Vernon Street back to the point of commencement.

## Polling Area No. 17A

Commencing at the junction of Haulover Creek and Oleander Street; thence south along the east-side of Oleander Street to Morning Glory Street; thence east along the north-side of Morning Glory Street to Partridge Street; thence south along the east-side of Partridge Street to Lark Spur Street; thence east along the south-side of Lark Spur Street to Zericote Street; thence south along the east-side of Zericote Street to Mahogany Street; thence west along the south-side of Mahogany Street to Partridge Street; thence south along the east-side of Partridge Street to Vernon Street; thence east along the north-side of Vernon Street to Central American Boulevard; thence north along Central American Boulevard to Haulover Creek; thence upstream along the south bank of Haulover Creek back to the point of commencement.

## ALBERT DIVISION

## Polling Area No. 16

Commencing at a point the said point being the junction of Sarstoon Street and Haulover Creek; thence south along the east-side of Sarstoon Street to Vernon Street; thence east along the north-side of Vernon Street to Thurton Lane; thence north along Thurton Lane to its production to Haulover Creek; thence upstream the south bank of Haulover Creek back to the point of commencement.

## LAKE INDEPENDENCE DIVISION

## Polling Area No. 17

Commencing at a point the said point being the intersection of the Western Highway and Burdon Canal; thence easterly along the north-side of the said Western Highway to a point having a scaled UTM coordinate of 371533 meters east and 1935066 meters north; thence north from said point to its intersection of Administrative Drive; thence north along the east-side Administrative Drive to its intersection with Haulover Creek; thence upstream along the south bank of Haulover Creek to its confluence with Burdon Canal; thence south-westerly along the south bank of Burdon Canal back to the point of commencement.

## Polling Area No. 17B

Commencing at a point on the Western Highway having a scaled UTM coordinate of 371533 meters east and 1935066 meters north; thence easterly along the north-side of the said Western Highway back to where it intersect with Vernon Street; thence along the north-side of Vernon Street to Partridge Street; thence north along the east side of Partridge Street to Mahogany Street; thence east along the south-side of Mahogany Street to Zericote Street; thence northerly along the east side of Zericote Street to Lark Spur Street; thence west along the Lark Spur Street to Partridge Street; thence northerly along Partridge Street to Morning Glory Street; thence west along the north-side of Morning Glory Street to Oleander Street; thence north along the east-side of Oleander Street to Haulover Creek; thence west along the south bank of Haulover Creek to its intersection with Administrative Drive; thence south along the eastern-side of Administrative Drive and extending to the Western Highway back to its point of commencement.

## COLLET DIVISION

## Polling Area No. 20A

Commencing at a point the said point being the junction of the Western Highway and Fabers Road; thence south-easterly along the north-side of Fabers Road to Jabiru Street; thence north along the west-side of Jabiru Street to Rio Grande Street; thence easterly along the south-side of Rio Grande Street; thence northerly to a point having a scaled UTM coordinate of 371491 meters east and 1934652 meters north; thence north to another point on the Western Highway having a scaled UTM coordinate of 371618 meters east and 1935049 meters north; thence west along the Western Highway back to the point of commencement.

## PORT LOYOLA DIVISION

## Polling Area No. 20

Commencing at a point the said point being the junction of Jabiru Street and Fabers Road; thence north along the west-side of Jabiru Street to Rio Grande Street; thence easterly along the south-side of Rio Grande Street and continuing east along the northern boundary of Hood's and Stephen's Estate to Central American

Boulevard; thence southerly along the east-side of Central American Boulevard to its junction with Fabers Road; thence westerly along the north side of Fabers Road back to the point of commencement.

## Polling Area No. 22

Commencing at a point the said point being the junction of the Central American Boulevard and Fabers Road; thence south-easterly along the north-side of Fabers Road to its intersection with Queen Charlotte Street and Caesar Ridge Road; thence east along the north-side of Queen Charlotte Street to Collect Canal; thence south along the west bank of Collect Canal to its confluence with the Caribbean Sea; thence southerly and westerly along the coast of the Caribbean Sea to it intersection with Port Authority Road; thence north along Port Authority road to its intersection with Ceasar Ridge Road; thence east along Ceasar Ridge Road to its intersection with Central American Boulevard; thence north along the Central American Boulevard back to the point of commencement.

## Polling Area No. 22 A

Commencing at a point the said point being the junction of the Western Highway and Fabers Road; thence south-easterly along the north-side of Fabers Road to its intersection with Central American Boulevard; thence southerly along the western side of the Boulevard to its intersection with Caesar Ridge Road.; thence west along southern side of Ceasar Ridge Road to the junction with the Port Authority; thence south along the Port Authority Road to its intersection with the coast of the Caribbean Sea; thence southerly and westerly along the coast of the Caribbean Sea to its confluence with Sibun Canal; then upstream along the north bank of Sibun Canal to its confluence with Burdon Canal; thence north-easterly along the south bank of Burdon Canal to its crossing with 'Toll Bridge' near mile five on the Western Highway; thence easterly along the north-side of the said Western Highway back to the point of commencement.

## BELIZE RURAL CENTRAL

## Polling Area No. 30

Commencing at a point, the said point being on the coast of the Caribbean Sea having scaled UTM coordinate of 1944488 meters north and 362937 meters east; the said point also being a survey property line; thence north west along the said survey property line to a point, said point having a scaled UTM coordinate of 1945309 meters north and 356111 meters east; thence south west to a point having a scaled UTM coordinate of 1945240 meters north and 355960 meters east, said point being its junction with the Northern Highway; thence southeast along the north-side of the Northern Highway to its junction with the Burrell Boom Road; west along the north-side of the Burrell Boom Road to intersection with the Belize River; thence downstream along the west bank of the Belize River to a point, the said point being the production of Javier Berbey Sr. Blvd. in the Vista Del Mar area to the river; thence northerly along the east-side of Javier Berbey Sr. Blvd to the coast of the Caribbean Sea; thence northerly along the coast of the Caribbean Sea back to the point of commencement.

The afore described Polling Area No. 30 generally comprising the villages of Lord's Bank, Bainton's Bank, Ladyville and all the settlements between the Northern Highway and the Sea from the Burrell Boom/Northern Highway junction to Belize River.

## COROZAL NORTH DIVISION

## Polling Area No. 41

Commencing at a point, the said point being the intersection of the northern Corozal Town Boundary and the coast at Corozal Bay; thence westerly along the said boundary to where it intersects the Northern Highway, also known as the Santa Elena Road; thence southeasterly along the north side of the Santa Elena Road to the southern boundary of parcel 874 in the Corozal North Land Registration Area; thence easterly along the
southern boundary of parcel 874 and continuing easterly along the southern boundaries of parcels 873,872 , 871, 1319, 1320, 1339, 1340 and 3351 all in the Corozal North Land Registration Area to an unnamed street; thence along the un-named street to the south-west corner of the Stadium; thence southerly and easterly along parcel 2456 to Toucan Street; thence along the north side of Toucan Street to 5th Street North; thence along the north side of 5th Street North to its production across Rainbow Beach to the coast at Corozal Bay; thence northerly along the coast back to the point of commencement.

## Polling Area No. 44

Commencing at a scaled UTM coordinate of 342120 meters east and 2026188 meters north which is the junction of the San Pedro Road and Northern Highway; thence east on the north side of the said Northern Highway for an approx. distance of 0.75 kilometers to a road; thence in a north easterly direction along the said road to its intersection with the Northern Highway at Calcutta Village; thence along the north side of the Northern Highway to the Patchacan Road; thence along the north side of the said road to its junction with the Yo Chen/Chan Chen Road; thence northerly along the west side of the Yo Chen/Chan Chen Road for a distance of approx. one kilometer to a property boundary, said point having a scaled UTM coordinate of 338916 meters east and 2039332 meters north; thence to a point on the south bank of the Rio Hondo having a scaled UTM coordinate of 344208 meters east and 2034992 meters north; thence downstream along the south bank of the Rio Hondo to a point east having a scaled UTM coordinate of 336667 meters east and 2030177 meters north; thence easterly direction to a scaled UTM coordinate of 338915 meters east and 2030193 meters north; thence southerly to a scaled UTM coordinate of 338890 meters east and 2029585 meters north being on a major track; thence continue along the major track to a scaled UTM coordinate of 341260 meters east and 2028674 meters north; thence south to as scaled UTM coordinate of 341260 meters east and 2028091 meters north; thence south east to a scaled UTM coordinate of 341843 meters east and 2027921 meters north on the San Pedro Road; thence southerly along the San Pedro Road back to the point of commencement.

The afore described Polling Area 44 generally comprising the villages of Patchacan, Kan Luum, Yo Chen, Cristo Rey, San Pedro, Laguna and Estero.

## COROZAL SOUTH WEST DIVISION

## Polling Area No. 51

Commencing at a point, said point being the junction of the San Pedro Road and the Northern Highway; thence east on the north side of the said Northern Highway for an approx. distance of 0.75 kilometers to the Calcutta Road; thence in a north easterly direction along the said road to a track; thence south along the said track to its junction with the Northern Highway; thence west along the Northern Highway for an approx. distance of one kilometer to a track; thence southerly along the said track to a point on a property boundary, the said point having a scaled UTM coordinate of 345684 meters east and 2026358 meters north; thence east to a major track; thence southwesterly along the said track to the Buena Vista/Libertad Road; thence south along the Buena Vista/Libertad Road to its junction with the Caledonia Road; the east along the Caledonia Road to a point, the said point having a scaled UTM coordinate of 340640 meters east and 2017193 meters north; thence southerly along a property boundary to the Corozal/Orange Walk District boundary; thence west along the said boundary to the Nuevo San Juan Road; thence northeasterly along the said road to the San Victor Road; thence east along the San Victor Road to its junction with a track and having a scaled UTM coordinate of 336690 meters east and 2018820 meters north; thence northerly along the said track to its junction with the Northern Highway; thence north along the Northern Highway to its junction with a track in Louisville; the westerly then easterly along the said track to a property boundary; thence south to a point having a scaled UTM coordinate of 338890 meters east and 2029585 meters north being on a major track; thence continue along the major track to a scaled UTM coordinate of 341260 meters east and 2028674 meters north; thence south to as scaled UTM coordinate of 341260 meters east and 2028091 meters north; thence south east to a scaled UTM coordinate of 341843 meters east and 2027921 meters north on the San Pedro Road; thence southerly along the San Pedro Road back to the point of commencement.

The afore described Polling Area No. 51 generally comprising the villages of Louisville, San Roman, Santa Clara, Concepcion and Buena Vista

# ORANGE WALK CENTRAL DIVISION 

## Polling Area No. 54

Commencing at a point the said point being the intersection of San Antonio Road and Fonseca Street; thence along Fonseca Street to San Andres Street; thence along the south-side of San Andres Street to Progress Street; thence along Progress Street to San Francisco Street; thence along San Francisco Street to its production to the New River; thence upstream the west bank of the New River to its junction with the production of Cemetery Street; thence west along Cemetery Street to Muffles Street; thence along Muffles Street to Santa Maria Street; thence along Santa Maria Street to Main Street; thence along Main Street to Mahogany Street; thence along Mahogany Street to Queen Victoria Avenue; thence along Queen Victoria Avenue to its junction with the San Antonio Road; thence west along San Antonio Road back to the point of commencement.

The afore described Polling Area No. 54 generally comprising part of the east portion of Orange Walk Town.

## ORANGE WALK NORTH DIVISION

## Polling Area No. 55

Commencing at a point the said point being the junction Orange Walk Town northern boundary and the New River; thence upstream along the west bank of New River to its junction with San Francisco Street; thence along the north-side of San Francisco Street to Progress Street; thence along the east side of Progress Street to San Andres Street; thence along the south-side of San Andres Street to Tate Street; thence along the east-side of Tate Street to Lyle Street; thence along the north-side of Lyle Street to Clarke Street; thence along the west-side of Clarke Street to Holy Trinity Street; thence along the west-side of Holy Trinity Street to its intersection with the northern boundary of Orange Walk Town; thence east along the said northern boundary of Orange Walk Town back to the point of commencement.

The afore described Polling Area No. 55 generally comprising the northeast portion of Orange Walk Town.

## ORANGE WALK EAST

## Polling Area No. 60

Commencing at a point the said point being the junction of the western boundary of Orange Walk Town and the San Antonio Road; thence southerly thence easterly along the said town boundary, a portion of which forms the Palmar Road to the west bank of the New River; thence downstream along the west bank of the New River to a point being Cemetery Road produced; thence westerly along Cemetery Road to Muffles Street; thence along Muffles Street to Santa Maria Street; thence along Santa Maria Street to Main Street; thence along Main Street to Mahogany Street; thence along mahogany Street to Queen Victoria Avenue; thence along Queen Victoria Avenue to the San Antonio Road; thence westerly along the San Antonio Road back to the point of commencement.

The afore described Polling Area No. 60 generally comprises the southern part of Orange Walk Town.

## CAYO CENTRAL DIVISION

## Polling Area No. 78

Commencing at a point, the said point being the confluence of Barton Creek and the Belize River; thence easterly along the south bank of the Belize River to its confluence with Quaco Creek; thence upstream along Quaco Creek to a survey line, said line being the production of the southern boundary of Valley of Peace; thence northeasterly along the said survey line to a road, said road being the western boundary of Valley of Peace; thence northerly along the said road to its intersection with the northern boundary of the Cayo District; thence westerly along the northern boundary of Cayo District to a road leading south to Los Tambos; thence south along the said road to the main road passing through Spanish Lookout agricultural layout; thence south along the said main road passing through Spanish Lookout to a road leading to the ferry; thence west and then south to a road leading to the ferry on the Belize River; thence across the Belize River and along the Baking Pot road to the Western Highway; thence west along the north-side of the Western Highway to its junction with a track leading south and connecting to Garbutt Creek, the said track opposite the area now or formerly known as Norland; thence upstream along Garbutt Creek for an approximate distance of 3.5 kilometers to a track; thence southerly then easterly along the said track to the Chiquibul Road; thence southerly along the Chiquibul Road for an approximate distance of four kilometers to a point having a UTM coordinate of 289269.5 meters east and 1890462.4 meters north, the said point being on the southern boundary of the Mary Hickey Land Registration area boundary; thence southeasterly along the said boundary to its junction with the west branch of Barton Creek; thence northerly and downstream along Barton Creek back to the point of commencement.

The afore described Polling Area No. 78 generally comprising the villages of Buena Vista, Gentle's Bank, More Force, Central Farm, Georgeville, Cool Shade, Seven Miles, Barton Creek, and surrounding communities.

## CAYO NORTH EAST DIVISION

## Polling Area No. 78A

Commencing at a point, the said point being the intersection of the northern boundary of the Cayo District and a major track, said track leading south to Los Tambos; thence south along the said road to the main road passing through Spanish Lookout agricultural layout; thence west and then south to a road leading to the ferry on the Belize River; thence upstream along the Belize River to its confluence with a creek south of Billy White Village; thence upstream along the said creek for a distance of approximately 0.8 kilometers to its intersection with a track; thence north along the said track to its junction with the Santa Familia road; thence northerly along the Santa Familia road to its intersection with a track east of Billy White Village; thence continuing northerly along the said track to its intersection with Billy White Creek; thence upstream Billy White Creek to a point, the said point having a scaled UTM coordinate of 280729 meters east and 1904523 meters north and being its intersection of a track; thence northerly along the said track to a point having a scaled UTM coordinate of 280 328 meters east and 1907281 meters north; thence continuing north along the said track to its junction with Cadena Creek; thence downstream along Cadena Creek to Aguacate Lagoon; thence along the west bank of Aguacate Lagoon to a track; thence northerly along the said track for a distance of approx. eight kilometers to the northern boundary of the Cayo District. Thence easterly along the northern boundary of the Cayo District for a distance of approx. nineteen kilometers to a major track and the point of commencement.

The afore described Polling Area No. 78A generally comprising Duck Run 1, 2 and 3, Los Tambos, and Spanish Lookout Village.
