## BELIZE RURAL NORTH

## Polling Area No. 23

Commencing at a point, the said point being he junction of the Crooked Tree Road and the Northern Highway; thence south along the Northern Highway for an approx. distance of 0.25 kilometers to its junction with a track; thence easterly then southerly along the said track to its junction with the Old Northern Highway; thence northerly along the Old Northern Highway for an approx. distance of ten kilometers to a property boundary; thence easterly along the property boundary to where its meets Midwinter's Lagoon; thence southerly along the bank of Midwinter's Lagoon to the coast on the Caribbean Sea; thence southerly along the coast to a point having a scaled UTM coordinate of 1944488 meters north and 362937 meters east; the said point also being a survey property line; thence north west along the said survey property line to a point, said point having a scaled UTM coordinate of 1945309 meters north and 356111 meters east; thence south west to a point having a scaled UTM coordinate of 1945240 meters north and 355960 meters east, said point being its junction with the Northern Highway; thence southeast along the north-side of the Northern Highway to its junction with the Burrell Boom Road; thence west along the north-side of the Burrell Boom Road to intersection with the Belize River; thence upstream along the south bank of the Belize River to its confluence with Burrell Creek; thence upstream along the east bank of Burrell Creek to its intersection with a track leading to Mussel Creek; thence northerly along the said track to its intersection with Mussel Creek; thence upstream along the east bank of Mussel Creek to its confluence with Francisco Creek; thence upstream along Francisco Creek to its intersection with survey property boundaries south of Maypen Village; thence generally westerly along the said property boundaries and across the Belize River to a point, the said point having a scaled UTM coordinate of 342265 meters east and 1950693 meters north; thence to a point having scaled UTM coordinate of 342041 meters east and 1950 867 meters north; thence to a point having scaled UTM coordinate of 341718 meters east and 1950444 meters north;
thence westerly along a property boundary to a point on the east bank of Southern Lagoon and having a scaled UTM coordinate of 338053 meters east and 1952345 meters north; thence northerly along the east bank of Southern Lagoon to a creek; thence downstream the said creek to its confluence with Northern Lagoon; thence northerly along the east bank of Northern Lagoon to its intersection with the Crooked Tree Road; thence easterly along the south side of the Crooked Tree Road back to the point of commencement

The afore described Poling Area 23 generally comprising the villages of Biscayne, Maypen, Sand Hill, Grace Bank, Davis Bank, Gardenia and all the settlements along the Northern Highway from the Burrell Boom Road Junction to the Crooked Tree Road junction.

## Polling Area No. 24

Commencing at a point, the said point being the intersection of the Belize District boundary and the Northern Highway; thence easterly along the said district boundary to its intersection with the coast at the Caribbean Sea; thence southerly along the coast to Midwinter's lagoon; thence northerly along the east bank of Midwinter's Lagoon to a survey property boundary; the easterly and then north westerly along the said property boundary to its intersection with the Corozalito Road; the westerly along the Corozalito Road to its Junction with the Old Northern Highway; thence northerly along the west side of the Old Northern Highway to its junction with a track leading to More Force; thence westerly along the said track to the east bank of Cutters Lagoon; thence southerly along the east bank of Cutters Lagoon to a creek; thence westerly along the said creek to a track; thence westerly along the said track to its junction with the Northern Highway; thence northerly along the east side of the Northern Highway back to the point of commencement.

The afore described Poling Area 24 generally comprising the villages of Maskall, Corozalito, Bomba, Nago Bank, St. Ann's and all the settlements on the Old Northern Highway from Corozalito to Rancho Creek Bridge and all the settlements on Northern River.

## Polling Area No. 25

Commencing at a point, the said point being he junction of the Crooked Tree Road and the Northern Highway; thence south along the Northern Highway for an approx. distance of 0.25 kilometers to its junction with a track; thence easterly then southerly along the said track to its junction with the Old Northern Highway; thence northerly along the Old Northern Highway for an approx. distance of ten kilometers to a property boundary; thence easterly along the property boundary to where its meets Midwinter's Lagoon; thence northerly along the west bank of Midwinter's Lagoon to a survey property boundary; the easterly and then north westerly along the said property boundary to its intersection with the Corozalito Road; the westerly along the Corozalito Road to its Junction with the Old Northern Highway; thence northerly along the west side of the Old Northern Highway to its junction with a track leading to More Force; thence westerly along the said track to the east bank of Cutters Lagoon; thence southerly along the east bank of Cutters Lagoon to a creek; thence westerly along the said creek to a track; thence westerly along the said track to its junction with the Northern Highway; the southerly along the Northern Highway back to the point of commencement.

The afore described Poling Area 25 generally comprising the villages of Lucky Strike, Rockstone Pond, Santana and Cowhead Creek.

## Polling Area No. 26

Commencing at a point, said point being on the east bank of Southern Lagoon and having a scaled UTM coordinate of 338053 meters east and 1952345 meters north; thence southerly along the east bank of Southern Lagoon to its confluence with a creek at its southernmost point; thence southerly along the said creek to a track; thence along the said track to the Bermudan Landing/Lemonal Road; thence northerly along the Bermudan Landing/Lemonal Road an across Spanish Creek to a track; thence westerly along the said track to its intersection with the Belize District boundary; thence northerly along the said boundary part of which forms Crab Catcher Lagoon and Poor Hall Creek to its confluence with Southern Lagoon; thence southerly along the east bank of Southern Lagoon back to the point of commencement.

The afore described Poling Area 26 generally comprising the villages of Lemonal and Wade Bank.

## Polling Area No. 27

Commencing at a point, the said point being the intersection of the Bermudan Landing Road and the Belize River; thence downstream along the Belize River to its junction with a track at Little Bermudan Landing; thence westerly then northerly along the said track to a creek; thence upstream the said creek to its confluence with Southern Lagoon thence northerly along the east bank of Southern Lagoon to a point, said point having a scaled UTM coordinate of 338053 meters east and 1952345 meters north; thence to a point having scaled UTM coordinate of 341718 meters east and 1950444 meters north; thence to a point having scaled UTM coordinate of 342041 meters east and 1950867 meters north; thence to a point having a scaled UTM coordinate of 342265 meters east and 1950693 meters north; thence generally easterly and across the Belize River along survey property boundaries south of Maypen Village; thence along the said boundaries
to its intersection with Francisco Creek; thence downstream along Francisco Creek to its confluence with Mussel Creek; thence downstream along Mussel Creek to its intersection with a track; thence southerly along the said track to its intersection with Burrell Creek; thence downstream along the east bank of Burrell Creek to its confluence with an unnamed creek west of Burrell Boom; thence upstream along the said creek to its intersection with the Burrell Boom Road, being approx. one kilometer west of the Burrell Boom/Hattieville junction; thence west along the north-side of the Burrell Boom/Bermudan Landing Road back to the point of commencement.

The afore described Poling Area 27 generally comprising the villages of Flowers Bank, and Scotland Halfmoon.

## Polling Area No. 28

Commencing at a point the said point being the intersection of Mussel Creek and the Burrell Boom/Bermudan Landing Road at Sebastian Bridge; thence upstream along Mussel Creek to its confluence with Cox Lagoon; thence along the west back of Cox Lagoon to its intersection with the Big Fall Road; thence westerly along the Big Falls Road to the Belize District Boundary; thence generally in a northerly direction along the Belize District boundary to a track leading to Lemonal; then easterly along the said track and across Spanish Creek to the Lemonal/Bermudan Landing Road; thence southerly along the Lemonal/Bermudan Landing Road to a track at Little Bermudan Landing; thence along the said track to where it meets the Belize River; thence upstream the Belize River to its intersection of the Bermudan Landing Road; thence easterly along the Bermudan Landing Road back to the point of commencement

The afore described Poling Area 28 generally comprising the villages of Bermudan Landing, Double Head Cabbage St. Paul's Bank, Big Falls, Willow's Bank, Isabella Bank and Rancho Dolores.

## Polling Area No. 29

Commencing at a point, the said point being the intersection of the northern Belize District boundary and the Northern Highway; thence southerly along the west side of the Northern Highway to its junction with the Crooked Tree Road; hence westerly along the Crooked Tree Road to Northern Lagoon, also known as Crooked Tree Lagoon; thence southerly along the east bank of Northern Lagoon to its confluence with a creek; thence westerly along the south bank of the said creek to its intersection with the Belize District boundary; thence northerly and easterly along the said Belize District boundary back to the point of commencement.

The afore described Poling Area 29 generally comprising the villages of Crooked Tree, and all the settlements along the Northern Highway from the Belize/Orange Walk District boundary to the Crooked Tree Road and all the settlements on the Crooked Tree Road.

## Polling Area No. 31

Commencing at a point, the said point being the intersection of the Burrell Boom Road and the Belize River; thence downstream along the west bank of the Belize River, to a point having a scaled UTM coordinate of 1939654 meters north and 355954 meters east; the due west to a point on the Boom/Hattieville Road; thence south along the Boom/Hattieville Road to a bridge situated 4 miles south of the village of Burrell Boom; thence west to a point having a scaled UTM coordinate of 1937951 meters north and

348404 meters east; the said point also being on the bank a an unnamed creek; thence northwesterly along the east bank of the said creek and across the Burrell Boom/Bermudan Landing Road; to its confluence with Burrell Creek; thence downstream along Burrell Creek to its confluence with the Belize River; thence downstream along the west bank of the Belize River back to the point of commencement.

The afore described Poling Area 31 generally comprising the village of Burrell Boom.
