CAYO NORTH EAST (New Division)

Polling Area No. 72

Commencing at a point, the said point being the intersection of Waight Avenue produced across Burns Avenue to the Macal River; thence west along the north-side of Waight Avenue to the Bullet Tree Road; thence continuing west along the north-side of the Bullet Tree Road to the western town boundary of San Ignacio; thence northerly along the western boundary of San Ignacio Town to the Mopan River; thence downstream along the Mopan River to its confluence with the Macal River in an area known as Branch Mouth; thence upstream the Macal River back to the point of commencement.

The afore described Polling Area No. 72 generally comprising the northern part of San Ignacio Town.

Polling Area No. 74

Commencing at a point, the said point being the intersection of the Mopan River and the western town boundary of San Ignacio; thence across the Mopan River to a track; thence northerly along the said track and crossing the Bullet Tree/Santa Familia Road to another track; thence north along the said track to a point having a scaled UTM coordinate of 280 328 meters east and 1907 281 meters north; thence southerly along a track to its intersection with a creek; thence downstream the said creek to its confluence with the Macal River; thence upstream along the Macal River to its confluence with the Mopan River in an area known as Branch Mouth; thence upstream the Mopan River back to the point of commencement.

The afore described Polling Area No. 74 generally comprising the villages of Branch Mouth, Santa Familia and Carmelita.

Polling Area No. 74A

Commencing at a point, the said point having a scaled UTM coordinate of 280 729 meters east and 1904 523 meters north and being the intersection of a track and a branch of Billy White Creek; thence southerly along the said track to its intersection with the Santa Familia Road to a point having a scaled UTM coordinate of 281 348 meters east and 1901 656 meters north; thence northerly along the Santa Familia road to its intersection with a track east of Billy White Village; thence continuing northerly along the said track to its intersection with Billy White Creek; thence upstream Billy White Creek back to the point of commencement.

The afore described Polling Area No. 74A generally comprising the village of Billy White.

Polling Area No. 77

Commencing at a point, the said point being the intersection of the Western Highway and the road leading to the ferry passing through Central Farm; thence west along the Western Highway to its junction with a track leading south and connection to Garbutt Creek, the said track opposite the area now or formerly known as Norland; thence south along the said track to Garbutt Creek; thence upstream along Garbutt Creek to a track leading to Pilgrimage Valley Settlement; thence westerly along the said track to Pilgrimage Valley; thence continuing westerly and then northerly along the said track to its intersection with Red Creek; thence northerly and downstream along Red Creek to its confluence with the Belize River; thence downstream along the north bank of the Belize River to its intersection with a road from Spanish Lookout, the area being the crossing of the ferry; thence south along the said road back to the point of commencement. The afore described Polling Area No. 77 generally comprising the villages of Esperanza, the settlements on the eastern side of Red Creek and San Miguel.

Polling Area No. 78A

Commencing at a point, the said point being the intersection of the northern boundary of the Cayo District and a major track, said track leading south to Los Tambos; thence south along the said road to the main road passing through Spanish Lookout agricultural layout; thence west and then south to a road leading to the ferry on the Belize River; thence upstream along the Belize River to its confluence with a creek south of Billy White Village; thence upstream along the said for a distance of approximately 0.8 kilometers to its intersection with a track; thence north along the said track to its junction with the Santa Familia road; thence northerly along the Santa Familia road to its intersection with a track east of Billy White Village; thence continuing northerly along the said track to its intersection with Billy White Creek; thence upstream Billy White Creek to a point, the said point having a scaled UTM coordinate of 280 729 meters east and 1904 523 meters north and being its intersection of a track; thence northerly along the said track to a point having a scaled UTM coordinate of 280 328 meters east and 1907 281 meters north; thence continuing north along the said track to its junction with Cadena Creek; thence downstream along Cadena Creek to Aguacate Lagoon; thence along the west bank of Aguacate Lagoon to a track; thence northerly along the said track for a distance of approx. eight kilometers to the northern boundary of the Cayo District. Thence easterly along the northern boundary of the Cayo District for a distance of approx. nineteen kilometers to a major track and the point of commencement.

The afore described Polling Area No. 78A generally comprising Duck Run 1,2 and 3, Los Tambos, and Spanish Lookout Village.
