# **ORANGE WALK NORTH**

# **Polling Area No. 55**

Commencing at a point the said point being the junction Orange Walk Town northern boundary and the New River; thence upstream along the west bank of New River to its junction with San Francisco Street; thence along the north-side of San Francisco Street to Progress Street; thence along the east side of Progress Street to San Andres Street; thence along the south-side of San Andres Street to Tate Street; thence along the east-side of Tate Street to Lyle Street; thence along the north-side of Lyle Street to Clarke Street; thence along the west-side of Clarke Street to Holy Trinity Street; thence along the westside of Holy Trinity Street to its intersection with the northern boundary of Orange Walk Town; thence east along the said northern boundary of Orange Walk Town back to the point of commencement.

The afore described Polling Area No. 55 generally comprising the northeast portion of Orange Walk Town.

#### Polling Area No. 56

Commencing at a point the said point being the junction Orange Walk Town northern boundary and the New River; thence westerly then southerly along the Orange Walk Town Boundary the San Antonio Road; thence westerly along the San Antonio Road to a secondary road east of Yo Creek and leading to San Lorenzo; thence northerly along the said secondary road to the San Lorenzo Road; thence across the San Lorenzo Road to a track; thence northerly along the said track to the San Roman Road; thence easterly along the San Roman Road to its junction with the Northern Highway; thence southerly along the Northern Highway for an approximate distance of 1.5 kilometers to a track; thence northerly along the said track for an approximate distance of 3.5 kilometers to a survey property line; thence easterly along the said survey property line to the west bank of the New River; thence upstream the New River back to the point of commencement.

The afore described Polling Area No. 56 generally comprising Trial Farm and settlements along the San Lorenzo Road.

# Polling Area No. 57

Commencing at a point the said point being the junction Orange Walk District northern boundary and the Rio Hondo; Thence easterly along the said boundary for an approximate distance of four kilometers to a road; thence southerly along the said road for and approximate distance of one kilometers to its junction with the Douglas Road; thence westerly along the Douglas Road for an approximate distance of one kilometer to a road; thence southerly along the said road a survey property boundary; thence westerly along the said boundary to a point, the said point having a scaled UTM coordinate of 328 474 meters east and 2011 658 meters north and being on a survey property boundary; thence westerly along the said boundary to the east branch of the Rio Hondo; thence downstream the east branch of the Rio Hondo to its confluence with the west branch of the Rio Hondo; thence downstream the Rio Hondo back to the point of commencement.

The afore described Polling Area No. 57 generally comprising the villages of Douglas and Nuevo San Juan.

# Polling Area No. 58

Commencing at a point the said point being the junction Orange Walk District northern boundary and the Northern Highway; thence south-easterly along the said northern boundary of the Orange Walk District to the San Estevan Road; thence southerly along the west-side of the San Estevan Road to a where it produces to the New River at San Estevan Village; thence southerly along the west bank of the New River for an approximate distance of 2.5 kilometers to a point, said point being on a survey property boundary; thence westerly along the said boundary to a track; thence southerly along the said track to its junction with the Northern Highway; thence westerly along the Northern Highway to the San Roman Road; thence along the San Roman Road to its intersection with the San Luis/San Lorenzo Road; thence northerly along the said road to a survey property boundary; thence westerly along the said boundary to a point having a scaled UTM coordinate of 328 474 meters east and 2011 658 meters north; thence northeasterly along a survey property boundary to a road; thence northerly along the said road to the Douglas Road; thence easterly along the Douglas Road for and approximate distance of one kilometers to its junction with a road; thence northerly along the said road to its intersection with the Orange Walk District northern boundary; thence easterly along the said boundary back to the point of commencement.

The afore described Polling Area No. 58 generally comprising the villages of San Pablo, San Jose and San Luis

# Polling Area No. 59

Commencing at a point, the said point being the intersection of the San Antonio Road and the east branch of the Rio Hondo; thence downstream the Rio Hondo for an approximate distance of four kilometers, the said point being on a survey property boundary; thence westerly along the said survey property boundary to its junction with the Rio Hondo; thence downstream the Rio Hondo to its confluence with its east branch; thence upstream the east branch of the Rio Hondo for an approximate distance of two kilometers to a survey property boundary; thence easterly along the said boundary to the San Luis/San Victor Road; thence southerly along the said road to its intersection with the San Roman road; thence easterly along the San Roman road for an approximate distance of 2.5 kilometers to a track; thence southerly along the said track to the Yo Creek/San Antonio road; thence northwesterly along the Yo Creek/San Antonio road to its junction with the east branch of the Rio Hondo; thence downstream the east branch of the Rio Hondo back to the point of commencement.

The afore described Polling Area No. 59 generally comprising the villages of San Lorenzo and San Roman.

# Polling Area No. 66

Commencing at a point, the said point being the confluence of the east branch of the Rio Hondo and the Rio Hondo, said point being the southern end of Albion Island; thence downstream the Rio Hondo, also forming a part of the international boundary between Belize and Guatemala, to a point on a survey property boundary; thence southerly along the said property boundary to a point having a scaled UTM coordinate of xxx meters east and xxx meters north, said point also being on the east branch of the Rio Hondo; thence upstream the east branch of the Rio Hondo back to the point of commencement.

The afore described Polling Area No. 66 generally comprising the villages of San Antonio-Rio Hondo, Santa Cruz and Campechito.
