Polling Area No. 109

Commencing point, the said point having a scaled UTM coordinate of 306277 meters east and 1781248 meters north and being on New Road; thence west to a point having a scaled UTM coordinate of 304442 meters east and 1781237 meters north; thence south to a point having a scaled UTM coordinate of 304442 meters east and 1778462 meters north, the said point being on the coast of the Caribbean Sea; thence northerly along the coast to the southern side of Prince Street; thence north west along the southern side of Prince Street to its intersection with the airstrip; thence south and around airstrip to its intersection with the southern side of New Road; thence north west along the southern side of New Road back to the point of commencement.

## Polling Area 113

Commencing at a point, the said point being at the confluence of Monkey River and the coast at the Caribbean Sea; thence upstream along the northern side of the Monkey River to its confluence with Black Creek; thence upstream along the northern bank of Black Creek to its intersection with the Southern Highway; thence south westerly along the eastern side of the Southern Highway to its intersection with Deep River save and except the villages of Medina Bank; thence downstream along the northern side of the Deep River to its confluence with the Caribbean Sea at the coast; thence northerly along the said coast back to its point of commencement.

The afore described Polling Area No. 115 generally comprising Monkey River and Punta Negra and all those areas to the northwest of Punta Negra up to the Southern Highway.

## Polling Area No. 116

Commencing at a point, the said point being the intersection of the San Felipe/Barranco Road and the coast on the Caribbean Sea, thence north west along the northern side of the said road to its intersection with Moho River; thence upstream along the northern bank of the Moho River to its confluence with Roaring Creek; thence south west along the east bank of Roaring Creek to a point having a scaled UTM of 280823 meters east and 1776056 meters north; thence south east to a point having a scaled UTM coordinate of 282765 meters east and 1772901 meters north, said point being on Sunday Wood Creek; thence down stream along the eastern bank of Sunday Wood Creek to its confluence with Temash River; thence downstream along the northern bank of Temash River to its confluence with the Caribbean Sea at the coast; thence northerly along the said coast back to the point of commencement.

The afore described Polling Area No. 116 generally comprising the villages of Barranco, Consejo Creek, Sunday Wood and Midway Village.

## Polling Area No. 117

Commencing at the junction of Savery Branch of the Sarstoon River and the Belize Guatemala International boundary; thence south easterly and downstream along the northern bank of Savery Branch to its confluence with Hiccatee Creek; thence upstream along the northern banks of Hiccatee Creek to its junction with Dolores Road; thence easterly along the northern side of the said road to its intersection with Temash River; thence downstream along the northern banks of Temash River to its confluence with the Caribbean Sea at the coast; thence southerly along the said coast to the North Bank of the Sarstoon River; thence upstream along the said north bank of the Sarstoon River to its intersection with the international boundary between Belize and Guatemala; thence north along the said international boundary back to the point of commencement.

The afore described Polling Area No. 117 generally comprising the villages of Crique Sarco, Sarstoon and Temash .

## Polling Area 118

Commencing at a point, the said point being the confluence of the northern banks of Sunday Wood Creek and Temash River, thence upstream along the eastern banks of Sunday Wood Creek to a point having a scaled UTM coordinate of 280823 meters east and 1776056 meters north; thence north westerly to a point having a scaled UTM coordinate of 282765 meters east and 1775901 meters north on the Roaring Creek; thence downstream along the eastern bank of Roaring Creek to its confluence with Moho River; thence upstream along the northern bank Moho River to its intersection with a secondary

east to a point having a scaled UTM coordinate of 302879 meters east and 1779651 meters north; thence to a point having a scaled UTM coordinate of 302884 meters east and 1778411 meters north; thence to a point having a scaled UTM coordinate of 304220 meters east and 1778399 meters north, said point being on the coast of the Caribbean Sea; thence along the coast to a point having a scaled UTM coordinate of 304442 meters east and 1778462 meters north; thence north to a point having a scaled UTM coordinate of 304442 meters east and 1781237 meters north; thence east to a point having a scaled UTM coordinate of 306426 meters east and 1781246 meters north; thence north east to a scaled UTM coordinate of 306509 meters east and 1781381 meters north;
thence east to a scaled UTM coordinate of 306655 meters east and 1781391 meters north; thence north east to a scaled UTM coordinate of 307205 meters east and 1782391 meters north and being on Papishaw Creek; thence downstream Papishaw Creek to a point having a scaled UTM coordinate of 307285 meters east and 1782317 meters north; thence north to a point having a scaled UTM coordinate 307292 meters east and 1782842 meters north; thence east to a point having a scaled UTM coordinate of 307685 meters east and 1782843 meters north; thence north to a point having a scaled UTM coordinate of 307692 meters east and 1783076 meters north; thence east to a point having a scaled UTM coordinate of 308163 meters east and 1783066 meters north; thence south to a point having a scaled UTM coordinate of 308158 meters east and 1782862 meters north, and being on the coast of the Caribbean Sea; thence northerly along the said coast back to its point of commencement.
